



REQUEST FOR PROPOSAL FROM THE WORLD INITIATIVE FOR SOY IN HUMAN HEALTH (WISHH)

I. DATE

March 20, 2024

II. PROJECT OBJECTIVE

The purpose of this Request for Proposal (RFP) is to identify a contractor to conduct a comprehensive assessment of the aquaculture industry in Kazakhstan. In 2020, the Kazakh government announced aquaculture is a priority sector. ASA/WISHH wants to better understand the aquaculture industry, its value-chain and identify potential partners to develop and implement an aquaculture program.

This assessment requires the expertise of an individual or firm that understands agricultural value chains and can recommend appropriate activities. This assessment should utilize a variety of information gathering techniques, and not rely solely on desk research. Other acceptable data collection techniques include in-person or virtual interviews. The ASA/WISHH team recognizes that reliable data may not be currently available for the Kazakh aquaculture sector. It is therefore important that submitted proposals take this into consideration and offer a sound methodology for data collection and analysis.

The market assessment will be used by ASA/WISHH on whether to develop and implement a Kazakh aquaculture program starting in 2025.

III. ORGANIZATION BACKGROUND

The American Soybean Association (ASA) was founded in 1920 by soybean farmers and extension workers to promote soy for high protein applications in developmental settings. Overseas activities initiated in the mid-1950s, and to date ASA has worked in over 80 countries. The World Initiative for Soy in Human Health (WISHH) was founded in 2000 to expand the work of the American Soybean Association (ASA) in developing and emerging markets to improve health, nutrition and food security, building the groundwork for future markets of soy. WISHH provides services in food technology, business development, nutrition services, and program and proposal development. WISHH expertise extends its network into additional areas, such as aquaculture and animal feed.

ASA/WISHH connects trade and development to strengthen agricultural value chains in emerging markets, creating trade and long-term demand for U.S. soy. Trade can improve lives

worldwide for both farmers and consumers. U.S. soy trade in emerging markets is pivotal to improve accessibility, affordability, and acceptability of high-quality plant and animal-sourced proteins in developing economies. Rising incomes in emerging economies generate further opportunity for trade. ASA/WISHH builds opportunity for long-term trade by improving agricultural value chains, human and animal nutrition, and farmer net incomes. ASA/WISHH initiatives broadly fit in two arenas: (1) trade-building long-term, early-stage market development, and (2) trade-building international agriculture and economic development. The St. Louis-based Program operates in sub-Saharan Africa, Asia and Central America.

ASA/WISHH offers proven feed sector capacity and decades of accumulated knowledge from ASA programs. Principal approaches include market and economic assessments, technical assistance and capacity building, food and feed trials and demonstrations, farmer field days, youth mentorship programs, food and feed value chain development, and market linkages.

ASA/WISHH achieves its mission by working in close partnership with: (1) the public sector (e.g., USDA, USAID, U.S. land grant universities, and host country governments), (2) the private sector (e.g., U.S. exporters and trade associations: Qualified State Soybean Boards and U.S. Soybean Export Council), and (3) private voluntary organizations. The Program draws upon the resources and experience of these partners and the services of a cadre of ASA/WISHH consultants with technical expertise in agricultural, international and commercial development spheres. ASA/WISHH relies on decades of experience in food commercial development and agricultural development programming. The Program takes pride in its growing portfolio of success with U.S. government-funding, including USDA (Food for Progress, McGovern-Dole, Global Broad-Based Initiative, Foreign Market Development, Market Access Program, Emerging Markets Program, Agricultural Trade Program, Emerging Markets Program, and Quality Samples Program) and USAID funding in both prime and sub-recipient capacities. ASA/WISHH has also attracted both private sector and other complementary funding sources from various donors to build on and leverage core funding from Qualified State Soybean Boards.

WISHH's objective is to increase the international consumption of soy protein in the human, livestock, and aquaculture sectors in new markets and thereby create new opportunities for soybeans and providing higher economic returns to U.S. soybean producers.

IV. SCOPE OF WORK

ASA/WISHH seeks the services of a company to provide unique and strategic insight into the following questions and topics. Each question or topic should be answered in the market assessment.

1. Consumers

- a. Who are the primary consumers of fish and how much fish are they consuming?
- b. What is the annual demand for fish (listed by species type)? presented in a table.

2. Distributors

- a. Current fish distribution channels (includes local and imported)
- b. Market weight/size/price/species (imports and locally produced) presented in a table

3. Feed producers

- a. Overview of the fish feed market (includes supply and demand, types of feed being produced locally and imported, quality of feeds, projected demand)
- b. Identify current fish feed producers in Kazakhstan and provide descriptions (contact information, company description, website, production capacity, utilized capacity, local demand, exports)
- c. Current feed distribution channels
- d. Current and planned fish feed projects (includes government and non-government investment in the industry)
- e. Raw materials sourcing
- f. Feed selling price per MT
- g. Description of common fish feed production technologies and equipment being utilized
- h. Opportunities and challenges for the feed industry

4. Local institutions

- a. Current government and non-government support programs for the aquaculture and feed production industries (e.g., financial, technical, regulatory, etc.)
- b. Listing of Universities with active aquaculture programs
- c. Current government policy and financial initiatives supporting the aquaculture industry

5. Fish producers

- a. Current fish production (listed in MT) by species
- b. Market growth potential for the next 5-10 years.
- c. Overview of common production systems
 - i. Volumes produced per system
 - ii. Geographic locations of aquaculture farms
- d. Fish production costs

6. Recommendations

- a. Should WISHH implement an aquaculture program in Kazakhstan?
- b. What activities should be implemented?
- c. What budgets are required for the recommended activities?

Project Deliverables (all materials should be presented in English):

- 1. One market assessment report addressing key questions and topics highlighted in the RFP
- 2. Works cited
- 3. A list of companies and individuals that contributed information and their contact information for follow-up
- 4. Presentation of final report and Q & A session

ASA/WISHH has an In-Country Representative in Kazakhstan that can recommend companies and organizations to interview, along with assisting to arrange in-country logistical support (hotel reservations, airport/hotel transfers and ground transportation). The consultant will pay for all hotels, meals, ground transportation and other in-country travel costs.

The maximum budget is \$43,000 which includes professional fees, overhead and travel. No other funding is available for this activity.

VI. SELECTION CRITERIA AND CRITERIA WEIGHTS

Proposals submitted will be evaluated according to the following criteria:

Comprehensiveness	35%
Consultant skills/experience	30%
Cost	20%
Timing	15%
TOTAL	100%

Special consideration will be given to Women or Minority Owned Small Business (WMOSB) entities with SBA certifications (proof of certification must be provided at time of submission).

VII. INSTRUCTIONS TO BIDDERS

Proposals must contain at a minimum the specific criteria requested in the Request for Proposal:

- 1. A description of the bidder's capabilities and experiences (can be submitted as a CV)
- 2. A proposal that includes the following sections
 - Proposal executive summary
 - Action plan to conduct the comprehensive assessment and potential travel
 - Proposed budget
- 3. Checklist of additional items that must be submitted:
 - Attachment A Technical Proposal Authorization Cover Page Completed and Signed
 - Full detailed proposal with executive summary
 - Proposal detailed budget
 - WMOSB Proof of Certification (if applicable)

Proposals should be submitted no later than 4:00 PM CDT on April 17, 2024. To be considered for the award, proposals must be submitted by e-mail to Alan F. Poock at apoock@soy.org.

Mr. Poock will confirm receipt of each proposal; if receipt has not been confirmed, your proposal has not been received.

If your proposal is not authorized by signature on Attachment A Proposal Authorization Cover Page, it may not be considered and may be rejected.

Submission of Questions: All questions regarding the preparation of proposals must be submitted in writing (by e-mail) to Alan F. Poock at apoock@soy.org **no later than 4pm CDT on March 29, 2024**. All questions and responses will be available on the WISHH <u>website</u> on or shortly after April 3, 2024. No questions will be answered over the phone or in person; all questions must be in writing and sent via email.
