



REQUEST FOR PROPOSAL FROM THE WORLD INITIATIVE FOR SOY IN HUMAN HEALTH (WISHH)

I. DATE

April 30, 2024

II. PROJECT OBJECTIVE

The American Soybean Association's WISHH Program (ASA/WISHH) is seeking analyses and recommendations of monetization options for FY24 USDA Food for Progress - Tanzania poultry proposal, including market analysis, preparation of a written monetization plan for inclusion in the proposal, and if successful, delivery of agent services to execute the monetization plan.

III. ORGANIZATION BACKGROUND

The American Soybean Association (ASA) was founded in 1920 by soybean farmers and extension workers to promote soy for high protein applications in developmental settings. Overseas activities initiated in the mid-1950s, and to date ASA has worked in over 80 countries. The World Initiative for Soy in Human Health (WISHH) was founded in 2000 to expand the work of the American Soybean Association (ASA) in developing and emerging markets to improve health, nutrition, and food security, building the groundwork for future markets of soy. WISHH provides services in food technology, aquaculture capacity building, poultry capacity building, business development, nutrition services, and program and proposal development.

ASA/WISHH connects trade and development to strengthen agricultural value chains in emerging markets, creating trade and long-term demand for U.S. soy. Trade can improve lives worldwide for both farmers and consumers. U.S. soy trade in emerging markets is pivotal to improve accessibility, affordability, and acceptability of high-quality plant and animal-sourced proteins in developing economies. Rising incomes in emerging economies generate further opportunity for trade. ASA/WISHH builds opportunity for long-term trade by improving agricultural value chains, human and animal nutrition, and farmer net incomes. ASA/WISHH initiatives broadly fit in two arenas: (1) trade-building long-term, early-stage market development, and (2) trade-building international agriculture and economic development. The St. Louis-based Program operates in sub-Saharan Africa, Asia and Central America.

ASA/WISHH offers proven feed sector capacity and decades of accumulated knowledge from ASA programs. Principal approaches include market and economic assessments, technical assistance and capacity building, food and feed trials and demonstrations, farmer field days, youth mentorship programs, food and feed value chain development, and market linkages.

ASA/WISHH achieves its mission by working in close partnership with: (1) the public sector (e.g., USDA, USAID, U.S. land grant universities, and host country governments), (2) the private sector (e.g., U.S. exporters and trade associations: Qualified State Soybean Boards and U.S. Soybean Export Council), and (3) private voluntary organizations. The Program draws upon the resources and experience of these partners and the services of a cadre of ASA/WISHH consultants with technical expertise in agricultural, international and commercial development spheres. ASA/WISHH relies on decades of experience in food commercial development and agricultural development programming. The Program takes pride in its growing portfolio of success with U.S. government-funding, including USDA (Food for Progress, McGovern-Dole, Global Broad-Based Initiative, Foreign Market Development, Market Access Program, Emerging Markets Program, Agricultural Trade Promotion Program, and Quality Samples Program) and USAID funding in both prime and sub-recipient capacities. ASA/WISHH has also attracted both private sector and other complementary funding sources from various donors to build on and leverage core funding from Qualified State Soybean Boards.

WISHH connects trade and development across global market systems, improving food security; and develops agricultural value chains in emerging markets, creating trade and long-term demand for U.S. soy.

IV. SCOPE OF WORK

1. **Analyses and Recommendations:** The consultant will complete market analyses leading to selection of recommended commodities for monetization in Tanzania to achieve program funding requirements as defined by ASA/WISHH. Per the below summary of [USDA guidance in the FY24 Food for Progress Notice of Funding Opportunity](#), the consultant must:
 - document commodity selection and potential costs and benefits of the sale to the economy of Tanzania.
 - document commodity appropriateness, both in Tanzania and for the U.S. agricultural industry.
 - demonstrate that the selection and quantity will not disrupt commercial sales or impact local production.
 - demonstrate local demand for the commodity and the impact thereof on cost recovery in the sale of the commodities to increase the likelihood of full planned budgets for program implementation.
 - demonstrate robust and thorough market analyses to inform commodity selection.

Monetization plan should include justification for selections to meet budget requirements including selection (from USDA list), demonstrate that a sufficient level of market analysis has been performed to determine the most appropriate commodity, quantity, timing, cost recovery estimates and freight costs, special needs and distribution methods and options for delivery given port infrastructure and tariff structures. Sales of specific commodities should not negatively impact the local market of a given commodity in Tanzania.

2. **Monetization Plan:** Based on analyses and recommendations generated in part (1) in accordance with [USDA proposal requirements](#) the consultant will write the monetization plan for

inclusion in the full proposal based on instructions outlined in the [FY 24 Food for Progress Notice of Funding Opportunity](#) (NOFO) and as directed and informed by the ASA/WISHH team and U.S. industry. The plan must be presented to ASA/WISHH for approval prior to submission of the ASA/WISHH proposal and will include all sections pertaining to monetization and commodity plan in the level of detail required in the NOFO, including but not limited to:

- A. Commodity list (Commodity, package size/type, commodity usage type, quantity in MT, destination country, delivery to U.S. port with timing, estimated sales price per MT, estimated proceeds.)
- B. Special needs and distribution methods
- C. Transportation and Storage
- D. Bagging and packaging
- E. Duty free entry
- F. Economic impact
- G. Impact on other sales
- H. Private sector participation in sales of commodity
- I. Reaching 70 Percent Minimum Return or Better
- J. Assuring receipt procedures
- K. Expected interest earned

3. **Sales Agent Services:** The consultant will provide sales agent services as the monetization agent if ASA/WISHH is selected for the Food for Progress – Tanzania award.

- A. Ensure highest possible cost recovery throughout the program by responding to USDA and ASA/WISHH requirements in revision of the monetization plan according to changing conditions and needs and freight budgets. Adjust plans in a timely manner in collaboration with ASA/WISHH and USDA to ensure effective plan execution.
- B. Serve as ASA/WISHH sales agent in charge of commodity sales from tender and advertisement through payment receipt in a timely manner.
 - 1. Update monetization plan per donor and ASA/WISHH input based on market changes
 - 2. Prepare tender documentation
 - 3. Advertise sale if using public tender methodology
 - 4. Review and summarize bids
 - 5. Recommend buyer
 - 6. Negotiate and prepare sale contracts
 - 7. Work with financial institutions to secure payments
 - 8. Prepare call forward for commodities
 - 9. Coordinate logistics and documentation with ASA/WISHH appointed freight forwarder
 - 10. Oversee timely receipt of payment.
- C. Sale of commodities must comply with USDA regulations 7 CFR 1499.

Performance Timeline

Parts 1 and 2 will be completed by or before June 18, 2024 – proposals should estimate time required to complete these phases. Part 3 timeline will depend on award and timing thereof.

Please include:

- Qualifications/capability statement, especially as it pertains to the outlined scope of work.
Please include:
 - Plan and timeline to acquire market information to execute an evidence-based monetization plan for inclusion in the proposal.
 - Experience acting as a sales agent for USDA Food for Progress, including markets, commodities, dates, cost recovery and other details that provide information about your organization’s past experience.
 - Details about any previous work experience in Tanzania.
- Proposed fee for services with applicable taxes clearly defined to complete the requirements above, with consideration that part (3) will only be required if ASA/WISHH receives an award. This section should be presented as a percentage of the total amount received from commodity sales and will cover all deliverables (parts 1, 2 and 3).
- CV for key consultant and/or applicant company.
- 2 to 3 references for recently completed monetization analyses, plans and sales.

VI. SELECTION CRITERIA AND CRITERIA WEIGHTS

Proposals submitted will be evaluated according to the following criteria:

Selection Criteria:

35% - Technical proposal to assess market and recommend options for monetization of commodity options in Tanzania

35% - Evidence of qualifications, experience and capabilities to execute the scope of work

30% - Cost proposal

Special consideration will be given to Women or Minority Small Owned Business (WMSOB) entities with SBA certifications (proof of certification must be provided at time of submission).

ASA/WISHH reserves the right to fund any or none of the applications submitted. ASA/WISHH reserves the right to cancel and reissue the solicitation. All costs incurred by the bidder or any third parties in the preparation of this proposal are the sole obligation of the bidder.

If your proposal is not authorized by signature on Attachment A Proposal Authorization Cover Page, it may not be considered and may be rejected.

All questions and answers will be available on the WISHH website by **May 10, 2024**. No questions will be answered over the phone or in person; all questions must be in writing and sent via email.
